



IASC guidance

**“Strengthening participation, representation
and leadership of local and national actors in
IASC Coordination mechanisms”**

- Adopted in July 2021 building on other relevant guidance and efforts (Interim IASC COVID guidance, GB workstream, etc)
 - Indicators that will be monitored – globally
 - Indicators that can be added – country-level
 - Aimed at country-level coordination mechanisms
 - Humanitarian Coordinators, Humanitarian Country Teams, Cluster and Inter-Cluster Coordination Groups, and other related Task Forces and Working Groups

Who is an L/NA?

- Local and national NGOs, including local civil society organizations (CSOs), such as: national non-governmental organizations (NNGOs) Red Cross/Red Crescent National Societies; human rights groups; women rights organizations (WROs); women-led organizations (WLOs)⁷ and girl-led initiatives; youth-led organizations; lesbian, gay, bisexual, transgender and intersex (LGBTI+) groups; faith-based organizations; organizations of persons with disabilities (OPD) as well as older persons' organizations.
- May also pertain to: national and local authorities, the local private sector and development-focused organizations, who may not define themselves as humanitarian actors *per se* but who may be contributing to humanitarian efforts.



According to 2020 IASC Coordination Mapping




% members of clusters/sectors/AoRs who are L/NAs



% of national-level clusters/sectors/AoRs that have L/NAs as leads or co-leads




% of national-level clusters/sectors/AoRs that have L/NAs as co-chairs or co-facilitators




% of national-level technical working groups that have L/NAs as leads or co-leads








% of subnational-level clusters/sectors/AoRs that have L/NAs as leads or co-leads








% clusters/sectors/AoRs holding coordination meetings in local/national language(s) or offering translation and interpretation



Localización: Experiencia del Clúster de Protección Colombia.

Marco Normativo Estatal y de Política Pública que reconoce el problema.

- **Prevención, Protección y construcción de soluciones para las víctimas.**
 - Ley 387/1997. Principios Rectores de Desplazamiento Interno.
 - Ley de Victimas y Restitución de Tierras 1448/2011, prorrogada por diez años.
 - Decretos Etnicos que son parte del marco normativo.
 - Incorporación de acuerdos de paz en materia de protección a victimas.
 - Coordinación Nación – Territorio. Como recurso estratégico
 - Responsabilidad de articularnos sin duplicar.
 - **Aún con la firma del acuerdo de paz, quedan conflictos por resolver.**



Articulación con actores locales - Nacionales en DDHH.

- **Personerías:** Actores locales de DDHH en todos los municipios del país:
 - Monitoreo.
 - Generación de confianza.
 - Construcción de redes locales de Protección.
- **Defensoría del Pueblo:** Sistema de Alertas Tempranas.
 - Defensores Comunitarios: Presencias territoriales en comunidades en riesgo.
- **Autoridades étnico-territoriales:**
 - Consejos Comunitarios (Pueblos Afro) Incidencia / Estructura Organizativa
 - Resguardos Indígenas.

Confinamiento: Reconocimiento.
- **Mesas Municipales de Participación Efectiva de Victimas.**
- **Juntas de Acción Comunal.**
 - RETO. Cierre de brechas.



Gestión de Equipos Locales.

- Cuatro Equipos subnacionales en los territorios de mayor recurrencia de emergencias. **Enfoque Área.**
 - Chocó, Cauca, Nariño (Costa Pacifica)
 - Norte de Santander. (Frontera con Venezuela)
 - 14 Equipos Locales de Coordinación. (Humanitaria / Paz y Desarrollo)
- Tres Áreas de Responsabilidad:
 - VBG, Acción contra Minas, Protección de la Niñez.
- Equipos compuestos por personal nacional. 90%
 - **Reto: Limitación de recursos financieros para motivar mejores respuestas locales.**

CPSS Co-Coordination Arrangement in north-east Nigeria

- The CPSS in northeast Nigeria was established in 2017 with 65% NNGO Membership
- The CPSS is led by the State Government Ministry of Women Affairs and Social Development and UNICEF
- In 2019, the Co-Coordination arrangement by a national NGO was introduced and Grow Strong Foundation was selected to become the co-lead.
- Thereafter a National Co-Coordinator was recruited and now works with the UNICEF International Coordinator to lead the CPSS.
- Grow Strong Foundation hosts the National Co-Coordinator

Progress in resourcing for coordination

- The Global Child Protection Area of Responsibility (Global CP AoR) and Street Child provided the funding for Co-Coordinator's position (2019-2021)
- UNICEF Nigeria is now supporting the costs for the Co-Coordinator's position for the next 12 months
- Main costs include salary and related personnel costs, transport/logistics and communication

Challenges encountered


- **Uncertainty** – there is always the worry where the next funding will come through. This year was difficult until UNICEF stepped in
- **Sustainability** – the position is tied to current project funding so when the project ends, that may well be the end of the national co-coordination arrangement.
- **Resourcing for coordination was not initially included** in Grow Strong Foundation Resource Mobilization Strategy
- **The nature of the work of the National Co-Coordinator calls for a reasonably ‘high’ salary** and which may not fit within the salary scale of the national NGO, this may cause some sort of discontent within the organization.

Opportunities exist

- **Advocacy opportunities:**
- **IASC Guidance** on Strengthening Participation, Representation and Leadership of Local and National Actors in the IASC Humanitarian Coordination Mechanisms
- **Grand Bargain 2.0** – with one of the focus being flexible and quality funding for local and national actors
- **Lessons learnt** e.g. making sure that resources for coordination is included in the GSF overall resource mobilization strategy
- **Local/National Co-leadership arrangements** are increasingly being seen as the right thing to do as well as good practice within the IASC humanitarian coordination mechanism


