Description of issue	During the meeting of the IDP Council, the need to organize leisure activities for IDP children for the summer period was identified	Under the old version of the Charter of the Territorial Community of the City of Khmelnytskyi, approved by the decision of the City Council of May 31, 2017 No. 5, (hereinafter referred to as the Charter), IDPs could not participate in general meetings or public hearings, submit local initiatives, establish self-organizing bodies of the population, vote for drafts of the local budget, and use other tools of local democracy. They were also not covered by local targeted programs aimed at supporting members of the territorial community, which could result in discrimination against IDPs	The territory of the Sartana territorial community has been fully occupied by the Russian Federation since February 2022. Former residents of the community who moved to Ukrainian-controlled areas did not receive necessary assistance in host communities	In 2022, the health and recreation program for children in need of special social attention and support, including IDP children, was suspended. Funding for the program in 2023 was also not provided. Most IDPs living in the community do not have social ties, and their difficult financial situation does not allow parents to organize active leisure, recreation and rehabilitation for children	During the meeting of the IDP Council in November 2022, the issue of implementing a project to establish a modular town in Chernivtsi, in which more than 200 people would be settled, was raised. However, during the discussion, the settlement procedure was not clear, in particular, the requirements for possible residents, approaches to selection, etc.
Tools used by the IDP Council to solve the issue	Through the involvement of partner organizations such as local business (children's room owners) and the Evangelical Church, a children's camp was organized at the church. This camp operated during the summer period and was accessible to IDPs and children from the host communities. Activities for children regularly held in the children's room are provided for IDP children at a discount	<ol style="list-style-type: none">1. The IDP Council prepared and submitted proposals for amendments to the Charter that would enable IDPs to participate in local democracy with the appropriate justification2. Members of the IDP Council were invited and actively participated in the meetings of the working group on the development of a new version of the Statute3. Members of the IDP Council held personal meetings with the head of the community, the legal department of the City Council	<ol style="list-style-type: none">1. Holding meetings of the IDP Council in an open format with the participation of IDPs from among former community residents who have moved to Ukrainian-controlled areas, and the head of the CMA2. Carrying out a survey among IDPs in order to study their needs and problems3. The IDP Council joined the development of a recommendation to amend two comprehensive programs of the Sartana village territorial community: the program of support and integration of IDPs and the program of social protection and support of Defenders of Ukraine, members of their families and members of the families of the deceased Defenders of Ukraine. The programs offer an expanded list of categories of people and families in need of support, as well as an expanded list of types of assistance and support for IDPs (both of which include IDPs from occupied areas)	<ol style="list-style-type: none">1. An analysis of the situation with the health and recreation of children in the Kropyvnytskyi community was carried out. The Council prepared an analytical report, which included a description of the current situation, analysis of problems and recommendations2. The potential need for rehabilitation of children in need of special social attention and support, including children from among IDPs, was calculated. The materials were considered during the meeting of the IDP Council, attached to the protocol and sent to the chairman of the executive committee3. A round table was held on child protection issues during the war in the Kropyvnytskyi territorial community in August 20234. A forum-theater workshop was conducted, and a regional forum-performance about the problems related to the integration of IDP children in the community was presented. IDPs themselves wrote the scenario and played in the performance. The forum-theater method is based on the involvement of the audience in finding a solution to a certain issue. Guests could also participate in the discussion and forum-performance by modifying the scenario according to the suggested resolution. Representatives of local authorities, members of the IDP Council and NGOs were invited to the performance	<ol style="list-style-type: none">1. The IDP Council recommended that the communal property department of the Chernivtsi City Council, when preparing the Settlement Procedure and the Standard Agreement for Accommodation of IDPs in the Modular Houses, take into account the proposals of the Council, in particular regarding the provisions of the Resolution of the Cabinet of Ministers of Ukraine dated April 29, 2022 No. 495, which defines measures for the formation of housing funds intended for temporary housing of IDPs and determines the order of provision of such housing2. The meeting of the IDP Council was attended by a representative of the City Council to provide updates on the situation of IDPs registered for temporary housing in the modular town, and on their settlement in the modular town3. The IDP Council took measures to inform IDPs about the need to register for temporary housing, in particular, with the help of CF “Right to Protection”, application forms and a memo on queuing for temporary housing in places of temporary residence in the city were distributed and explanations were provided; relevant information was published in IDP communities in social networks

Positive impact of solving the issue on IDPs in the community	The organization of the summer camp has had a positive impact on the integration of IDP children who have the opportunity to attend classes and participate in recreational activities with children from the host community	The new version of the Charter provides that “Internally displaced people registered on the territory of the community may, without restrictions, with the right to vote, participate in all forms of citizen participation in local self-government provided for in this Charter” (Art. 43). As a result, barriers to the participation of IDPs in community life have been removed, in particular through the use of local democracy tools	The budget for social protection in 2024 has increased significantly and provides for UAH 14 million compared to UAH 3 million in 2023. The budget covers a wider list of types of material assistance to support groups of people and families of IDPs who are former residents of the Sartana Territorial Community and live in Ukrainian-controlled areas. Since December 2022, the Sartana CMA has launched the Single Portal for informing people. The Portal is used to communicate with former residents of the community who moved to the Ukrainian-controlled areas. Operators interview such people about their needs and inform them about the opportunities and mechanisms for receiving help. Sartana CMA keeps track of every family that has moved, updates information every month about changes that occur in the family (family members, additional difficult life circumstances, needs, re-displacement, etc.). As a result, former residents of the community who moved to Ukrainian-controlled areas are informed about the possibility of receiving assistance from the local budget of the Sartana CMA	The City Children's Health and Recreation Program for 2024-2026 has resumed, which provides for the health and recreation of children who need special social attention and support, including IDP children. The total amount of financial resources has been increased to UAH 11.6 million. It is planned to cover 30% of the total number of schoolchildren in grades 1-8. As a result, the activities of the IDP Council had a positive impact on both IDPs and residents of the host community	IDPs living in the community who need accommodation can consider the possibility of temporary housing in a modular town and register for other temporary housing solutions for IDPs, receive temporary housing through a transparent settlement algorithm, without losing their place in the register for other temporary housing solutions for IDPs
