

Humanitarian Network and Partnership Week: Leverage Protection Risks Analysis to Inform Joined-Up Collective Actions

Concept Note & Agenda

Background

Understanding protection risks in context is not only critical for shaping humanitarian policy but is also fundamental to prioritizing life-saving operations and ensuring that resources reach those most in need. The Global Humanitarian Overview (GHO) 2025 underscores that the escalating harm to civilians, driven by armed conflict and widespread disregard for international humanitarian and human rights law, remains a key driver of humanitarian needs. In an era marked by deepening financial constraints, dwindling humanitarian funding, and escalation of humanitarian crises, there is an urgent imperative to rethink efficiency, strengthen prioritization, and align humanitarian responses to maximize impact, while encouraging others to contribute to the collective effort.

At the heart of this crisis lies a fundamental challenge: how to do better with less, without compromising the core humanitarian commitment to protection. While protection analysis is foundational, its true value is realized when it can be used to guide difficult decisions about where and how to allocate limited resources. Achieving this requires moving beyond fragmented approaches and adopting a collective, evidence-based strategy that positions the reduction of protection risks as a central component of humanitarian efficiency and effectiveness.

Protection risk analysis is a key enabler of smarter, more effective humanitarian action. It provides the basis for robust prioritization of response efforts, ensuring that resources are channeled where they are most needed, while preserving the ability to scale up when necessary. This session will examine how protection risk analysis, when used strategically, can support broader efforts to strengthen efficiency, reduce violence, save lives and maintain critical interventions, ensuring that the humanitarian response remains fit for purpose in the current financial crisis.

Objectives

This session will feature insights from donors, GPC, OCHA and non-protection actors, sharing key lessons and practical opportunities for leveraging protection risk analysis to drive collective, strategic action amidst financial and operational constraints. It will emphasize the alignment of humanitarian coordination with field-driven solutions, ensuring that protection analysis supports faster, more effective decision-making on where and how to intervene. The discussion will focus on practical steps for integrating protection risk analysis into humanitarian prioritization processes, financing decisions, and response strategies, ensuring that humanitarian action remains responsive, efficient, and life-saving while encouraging others to take up the effort.

Target Audience

The meeting is designed to bring together senior officials from Member States and donors engaged in humanitarian action, alongside key stakeholders shaping response strategies in crises. It will be open to a diverse range of participants, including coordination teams, technical leads and decision-makers from UN agencies, international and local NGOs, as well as representatives from global clusters and development actors. By fostering cross-sectoral dialogue, the event aims to engage both those actively supporting humanitarian programming, those actively working on protection, as protection partners and technical leads, and those

influencing broader policy and operational frameworks, ensuring a more inclusive and comprehensive discussion on protection and humanitarian response.

The event is part of the Humanitarian Network and Partnership Week (HNPW) and will be promoted through both HNPW communication and GPC external communication channels. The event will take place in Geneva with remote connection possible.

Expected Outcomes

- Identify potential practical mechanisms to integrate protection risk analysis into humanitarian
 decision-making and response prioritization, ensuring that actions are based on greatest risks and
 resulting needs facing affected populations, and operational feasibility rather than rigid structures.
- Identify ways of strengthening cross-sectoral collaboration where **protection risk analysis serves as an enabler** to enhance operational efficiency, reduce duplication, and ensure protection is integrated as a core component of humanitarian action rather than treated as a separate, siloed effort.
- Develop recommendations for both protection and non-protection actors on the joined-up use of
 protection risk analysis as a driver for more effective prioritization and resource allocation, ensuring
 it informs humanitarian planning and response.
- Explore ways to leverage protection risk analysis to drive actionable strategies.
